- Each year, application renewals will be available in your account in early January and must be submitted no later than February 15.

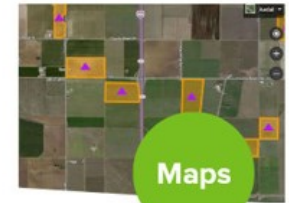

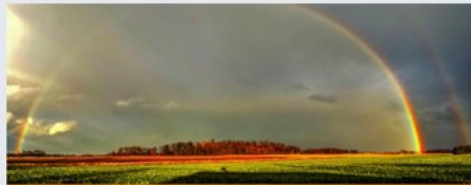
